## THE CANADIAN ECONOMY

UNEMPLOYMENT—REQUEST FOR DETAILS OF EMPLOYMENT CREDIT SCHEME—POSSIBILITY OF NEW MEASURES

**Mr. Sinclair Stevens (York-Simcoe):** Mr. Speaker, in the absence of the Minister of Finance I will address my question to the Prime Minister. With today's unemployment figures confirming that regional disparities in our country with respect to the jobless are widening, for example, one in five of our youth in the Atlantic provinces now being out of work and over 50 per cent of those in the construction industry in Saint John, New Brunswick, being without jobs, would the Prime Minister confirm, as did the Minister of Finance, that we shall continue to experience an unemployment level of 8.3 per cent and that 1.1 million may well be without jobs during the winter months?

**Right Hon. P. E. Trudeau (Prime Minister):** No, Mr. Speaker, I would not confirm that.

**Mr. Stevens:** Having regard to today's disappointing unemployment figures would the Prime Minister tell us when we may expect further elaboration of the employment credit scheme first announced by the Minister of Finance on October 20, bearing in mind that if the scheme is to have any effect on unemployment this winter it must be implemented immediately?

**Mr. Trudeau:** Well, Mr. Speaker, the minister did indicate, as we have already indicated in the Speech from the Throne, that we wanted to move forward with this plan. We would be very appreciative if the opposition would co-operate in getting the stimulative measures which are now before the House passed, notably the tax cuts which the minister has moved, so that we can pass on to the next measure.

**Mr. Stevens:** A final supplementary question, which again I will address to the Prime Minister, Mr. Speaker. The Prime Minister asks us to expedite that piece of legislation, but as he will realize, the bill was introduced only yesterday. With unemployment becoming more and more chronic in the country, particularly in Quebec where over 40 per cent of those out of work and looking for jobs have been out of work for three months or longer, would the Prime Minister indicate whether we have seen his entire government's program to relieve unemployment? Has it all been announced to the extent that it is available? In short, did he come up with any new plans which we could hear about while he was snorkeling in the Bahamas?
