DISASTROUS FIRES.

Large Blazes in San Francisco and Minneapolis.

FIVE FIREMEN ARE KILLED.

A Night of Terror in the Pacific Metropolitan—Water Pumped from the Sea to Fight the Flames—Help from Sister Cities—Loss Over \$1,500,000.

San Francisco, June 30.—A fire started shortly before six o'clock Thursday night in the rear of the San Francisco box factory at Fifth and Harrison streets. Before the department reached the ground the flames were sweeping through a number of frame buildings on Fourth St., which backed into the box factory, and had leaped across the street to the East End Hotel.

The chief sent out alarm after alarm and soon saw that the fire was beyond control.

Help from Sister Cities.

He wired across the bay to Oakland and Alameda, and each of the sister cities sent two engines.

They were located along the waterfront, and used as pumps to supply water from the bay.

The Southern Pacific pumps had lines of hose connected, and did good service in bringing salt water to supply the fast weakening fresh water mains.

A strong wind was blowing from the west, and fanned the flames across the broad streets, sweeping everything in its path.

A Wall Stops the Sweep of Flames.

At 9 o'clock the fire was under control. The high brick wall of the de-posed Southern Pacific offices at Fourth and Townsend streets acted as a barrier, over which the flames could not work.

The water-furnishing companies by the Oakland engines and Southern Pacific pumps soon had the outer edge of the fire subdued.

Homeless and Dead.

Three hundred families are homeless through some of them managed to save a portion of their goods.

A conservative estimate of the loss is \$1,500,000. There is about \$800,000 in insurance.

SIX FIREMEN KILLED.
