SYNOPSIS OF COAL MINING REGULATIONS

Coal mining rights in the Dominion of Manitoba, Saskatchewan and Alberta, the Yukon Territory, the Northwest Territories and in a portion of the Province of British Columbia may be leased for a term of twenty-one years at an annual rental of \$1 an acre. Not more than 2,560 acres will be leased to one applicant. Applications for a lease must be made by the applicant in person to the Agent or Sub-Agent in the district in which the rights applied are situated.

In surveyed territory the land must be described by sections, or legal subdivisions of sections, and in unsurveyed territory the tract applied for shall be staked out by the applicant himself. Each application must be accompanied by a fee of \$5 which will be refunded if the rights applied for are not available, but not otherwise. A royalty shall be paid on the merchantable output of the mine at the rate of five cents per ton. The person operating the mine shall furnish the agent with sworn returns accounting for the full quantity of merchantable coal mined and pay the royalty thereon. If the coal mining rights are not being operated, such returns shall be furnished at least once a year. The lease will include the coal-mining rights only, but the lessee may be permitted to purchase what ever available surface rights may be considered necessary for the working of the mine at the rate of \$10.00 an acre.

WHY ADVERTISE?

There are still some merchants who have not found a reason even yet. They are not convinced that at any time it pays to Advertise, but when times are good they may take a chance. Come hard times they stop at once.
