## PRIVILEGE

MR. CHURCH—REFERENCE TO REPORT IN TORONTO "EVENING TELEGRAM"

Mr. T. L. CHURCH (Broadview): Mr. Speaker, I rise to a question of privilege. Yesterday in the house I asked the following question about the embargo on Canadian cattle to the United States—and I may say that the question has been on the order paper since Tuesday, June 8:

1. Has any action been taken as announced by the Minister of Agriculture last week in south Ontario that the cattle embargo is soon to be removed to allow Canadian cattle to enter the United States?

2. If so, will such action increase the cost of meat to citizens for home consumption in Canada?

3. Has any action been taken by order in council?

The answer I received yesterday was as follows:

Mr. McCubbin:

1. No action yet taken.

2 and 3. Answered by No. 1.

I wish to call the attention of the house to a garbled report of this question and answer on a serious problem which appeared in the Toronto Evening Telegram of yesterday, June 14. Several members of the house asked a similar question on the orders of the day yesterday. I should like a correction to be made in the record accordingly.

## DIPLOMATIC SERVICE

SUPERANNUATION—PROVISIONS AS TO RETURN OF CONTRIBUTIONS, ETC.

Right Hon. L. S. ST. LAURENT (Secretary of State for External Affairs) moved that the house go into committee at the next sitting to consider the following resolution:

That it is expedient to present a bill to amend the Diplomatic Service (Special) Superannuation Act, to provide for the return to a public official or his widow, under certain circumstances, contributions made under such act; to give a right to a public official to elect not to become a contributor under the act and to provide that withdrawal allowances and gratuities shall be paid out of the consolidated revenue fund.

He said: His Excellency the Governor General, having been made acquainted with the subject matter of this resolution, recommends it to the consideration of the house.

Motion agreed to.

### AMMONIUM NITRATE

REFERENCE TO QUESTION DROPPED FROM ORDER PAPER

#### COST OF LIVING

INQUIRY AS TO GOVERNMENTAL ACTION

On the orders of the day:

Mr. DONALD M. FLEMING (Eglinton): Mr. Speaker, yesterday I asked the government whether it would welcome a report from the prices committee, and if so, and the committee brought in a report, whether the government would set aside ample time for its discussion. The Minister of Finance in reply said that he would draw the question to the attention of the leader of the house. Is the Prime Minister in a position to make a statement now?

Right Hon. W. L. MACKENZIE KING (Prime Minister): I would say to my hon. friend that as to the time to be allotted to particular measures I think we should seek to accommodate each other, but I do not wish to make too many commitments in advance. A good deal will depend upon the progress we make in expediting the business of the house. I do not wish to make any commitments without regard to all sides of the situation, so far as these can be ascertained.
