### Questions

a motion for further particulars was refused by the court; October 26 and November 9 when the case could not proceed as a magistrate was not available. The case came on for hearing on November 23, at which time, after the informations were read, counsel for the taxpayer raised four objections to the informations before entering any pleas. The case was then adjourned until November 24, at which time the magistrate ruled against the taxpayer on three of the motions but did not adjudicate on the fourth. The magistrate and counsel for the crown were then served with an application for writ of prohibition, which writ was returnable in Toronto on December 4. Upon advice of counsel, the application was not opposed by the crown and a writ of prohibition was granted on December 4. The informations were withdrawn on December 11.

With respect to the informations laid on January 21, 1960, there have been no court proceedings or hearings.

### COAL EXPORTS TO JAPAN

## Question No. 203-Mr. Kindt:

1. What tonnage of coal was shipped to Japan from Alberta and British Columbia in the calendar years 1958 and 1959, and what was the respective amounts of federal coal subventions on these shipments?

2. Is there a Canadian coal mission in Japar at present? If so, is there anything to report?

3. What is the estimated tonnage of Canadian

3. What is the estimated tonnage of Canadiar coking coal likely to be shipped from Alberta and British Columbia to Japan during the current calendar year?

## Answer by: Hon. Paul Comtois (Minister of Mines and Technical Surveys):

- 1. In the 1958 calendar year, 24,730 tons were shipped to Japan from Alberta and British Columbia at a subvention cost of \$81,943.59. In the 1959 calendar year, 189,607 tons were shipped to Japan from Alberta and British Columbia at a subvention cost of \$832,899.70.
- 2. An official Canadian technical and scientific mission, sponsored by the dominion coaboard, is in Japan conducting studies designed
