3. The government has set up an interdepartmental committee consisting of interested departments and agencies under the chairmanship of the Department of the Secretary of State. Its purpose is to organize the activities of public and private bodies, particularly professional book associations.

4. Yes; the amount provided is \$400,000.

6. The Secretary of State Department is organizing broad consultations in March with the provinces, numerous professional organizations and individuals interested in books, for the purpose of developing a complete program for the year and stimulating public participation.

Sir, it is bad enough not to be able to get answers to questions asked orally in the House of Commons but it is worse when the government deliberately flouts the practice of the House with reference to starred questions.

STATEMENT BY PRIME MINISTER CONCERNING REFUSAL BY PERSONS RECEIVING UNEMPLOYMENT INSURANCE BENEFITS TO ACCEPT JOBS

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, I always feel strong in the presence of the hon. member for St. Boniface. I have a question for the right hon. the Prime Minister. In view of the statement made by the Prime Minister, and I quote, "You know, there are people on unemployment insurance who prefer not to work and they have a perfect right to make that decision", I would ask him when the laws of this country were changed to justify that statement?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I must have missed something because I did not understand the question.

Mr. Diefenbaker: Nobody understood your statement.

Mr. Stanfield: In view of the statement the Prime Minister made over the weekend that "there are people on unemployment insurance who prefer not to work and they have a perfect right to make that decision ... should be no stigma attached to them ... they paid their unemployment insurance", can the right hon. gentleman tell the House when the law of this country was changed to make—

Mr. Speaker: Order, please. I have no objection to allowing the right hon. Prime Minister to answer but certainly that is argument. I suggest to the hon. gentleman who is asking the question that he might like to rephrase the question or ask a supplementary.
