MOSQUITO CONTROL

Question No. 676-Mr. Jones:

1. Have any departments or agencies of the government caused any studies to be made with respect to mosquito population and mosquito control by insecticides and natural means and, if so (a) on what dates were these studies made (b) what were the recommendations?

2. Do the Ministers responsible intend to take some action to eliminate the mosquito problem in this country by natural means?

Hon. E. F. Whelan (Minister of Agriculture): 1. Yes, Agriculture Canada. The Canada Committee on Biting Flies was formed in 1973 under the auspices of Agriculture Canada to analyze the problem of biting flies which include mosquitoes and to recommend action which would be expected to alleviate the problem. The committee consists of representatives from provincial agriculture departments, universities and federal departments with an interest in biting fly problems. The committee is encouraging several approaches including the development of ecologically-acceptable chemical control agents and alternatives to pesticides particularly those with the greatest promise of early application and adoption. (a) The department's research program includes two projects related to mosquitoes which commenced prior to the formation of the committee. (b) The studies have not reached the stage where recommendations can be made.

2. Any action to be taken will depend upon the results and recommendations emanating from the projects currently in progress.
