what will not be done before the date of adjournment because we do not know what the date of adjournment will be.

Mr. Skelly: Madam Speaker, I would like to say that it would certainly be sufficient if the Government House Leader could consult and attempt to provide the House and the country with that kind of information prior to sitting. That would then provide us with an opportunity to respond in a possibly very effective and quick way in the fall should those programs be suitable.

Mr. Lewis: Madam Speaker, at our caucus meeting on Wednesday of next week we will be discussing whether or not our Party might grant unanimous consent to bring that motion forward on the Thursday rather than on the Wednesday in order that the time allotted for Private Members' Business will not be infringed upon. I will communicate that to the Government House Leader at a later time.

Mr. Pinard: Madam Speaker, we are not in the hands of the Tory caucus on this issue. We follow the rules. The Special Committee on Parliamentary Reform proposed, and it was accepted unanimously, that the motion to extend the hours, if there is no agreement, must be moved on the tenth sitting day before June 30 this year. The Committee knew that. It so happens that the tenth sitting day before June 30 is a Wednesday. I hope that the Tories will agree to that, but failing that agreement, we will certainly not be dictated to by what the Tory caucus decides.

MARITIME FORESTRY COMPLEX, FREDERICTON, N.B.

Question No. 4,837—Mr. Howie:

To the date on which this question is answered, what is the status of the Maritime Forestry Complex which is to be built at Fredericton, New Brunswick?

Hon. John Roberts (Minister of the Environment): The federal Government has confirmed its participation in the construction of the Maritimes Forestry Complex as part of its Forest Sector Strategy for Canada, under the Special Capital Recovery Projects Program. As announced on May 18 by the Hon. John Roberts, Minister of Environment Canada and the Hon. Roméo LeBlanc, Minister of Public Works, the Government will construct new facilities for the Maritimes Forest Research Centre of the Canadian Forestry Service. These facilities, estimated to cost \$22 million, will be part of the Complex which will also include the New Brunswick Department of Natural Resources, the University of New Brunswick Forestry Research Group and the Maritimes Forest Ranger School.
