Hon. John C. Munro (Minister of Indian Affairs and Northern Development): Mr. Speaker, it is strange to hear the Hon. Member being critical now when we are just on the advent, much to the consternation of those who oppose any land claim settlements with natives at all, of moving ahead in what I think is a very historical moment in the North with a final settlement on COPE, which the Hon. Member and his Party have always wanted, and when we just signed an agreement in principle with the Council of Yukon Indians on another major comprehensive claim in the Yukon. All this Member can do is stand up and start to criticize both claims, I take it, I do not know. If he is, let him realize that he is also insulting and criticizing the native interests both of the CYI and in COPE.
