INVESTMENT TAX CREDITS—REACTIVATION SOUGHT FOR ENERGY EXPLORATION SMALL BUSINESSES

Mr. Albert Cooper (Peace River): Mr. Speaker, in the absence of the Minister of National Revenue, my question is directed to the Parliamentary Secretary. The Department is well aware that small businesses directly involved in oil and gas activity, particularly seismic lines and well site preparation, have been denied investment tax credits on the equipment used by them in these particular operations. This is of great concern to a riding like Peace River, because it can literally mean hundreds of jobs.

Will the Department address the situation and reactivate the use of these investment tax credits for these people, so we can ensure that we can protect these jobs for the people in Peace River and other parts of the oil and gas industry?
