TRIBUTE TO A GREAT POLITICIAN

Mr. Gabriel Desjardins (Témiscamingue): On September 26, in Rouyn—Noranda, Mr. Speaker, I dedicated on behalf of the Department of Public Works a federal building as a memorial to Mr. Réal Caouette.

GOVERNMENT PROGRAMS TO ASSIST FARMERS

Mr. Geoff Wilson (Swift Current—Maple Creek): Mr. Speaker, over the past two years the Government has amended the Western Grain Stabilization Act to permit timely interim payments, instituted an immediate lifetime capital gains tax exemption, doubled the advance payment for crops, enacted federal farm fuel rebates in excess of 30 cents per gallon, improved Canada-provincial crop insurance programs, put over \$200 million into crop and livestock drought assistance, and negotiated the inclusion of agriculture into the GATT talks. These initiatives, coupled with those of the Government of Saskatchewan, have injected over \$2 billion into the Saskatchewan economy alone.

Now there has been a commitment in the Throne Speech to work with Premier Devine and other provincial Governments and with farm organizations to devise an appropriate assistance package that will deliver an estimated \$1 billion to enhance the cash flow of the Canadian grain farmer. Never before in our history have any two levels of government, working together, made such a response to Canadian agriculture.

WESTERN GRAIN FARMERS—ANNOUNCEMENT OF ASSISTANCE

Right Hon. John N. Turner (Leader of the Opposition): Mr. Speaker, could the Prime Minister confirm that the announcement he made on behalf of western grain farmers during the course of his intervention in the Throne Speech debate last Friday was made only as a result of a 5.30 a.m. phone call from Premier Devine to two federal cabinet Ministers during which the Premier is quoted in the Saskatoon Star-Phoenix as having said: "If I lose over this, it's going to be damned tough for Mulroney next time around"? Is that the reason why the Prime Minister made a last minute, undetailed effort on behalf of western grain producers?

Right Hon. Brian Mulroney (Prime Minister): Mr. Speaker, the initiative that was set forward followed a meeting of Agriculture Ministers in Victoria held on August 27, 1986, at which the Ministers supported the need to examine all options including deficiency payments which could be in excess of \$1 billion to maintain the competitive position of Canadian producers in the immediate future. There was at the conference a clear, collective commitment to take action to support the agricultural sector and all the jobs it represents across Canada during this damaging trade war. That meeting was held on August 27. There were meetings subsequent to that,
