in 1928. Due to challenges from other states (mainly Wisconsin), there have been several U.S. Supreme Court decrees issued (1922, 1925, 1930 and 1967). The 1967 decree limited the diversion to an average of 3,200 cfs effective March 1, 1970. A 1980 court amendment allows the use of a 40-year period in calculating long-term average diversion for compliance. Lake Michigan is located entirely within the United States territory and is not considered as "boundary water" according to the Boundary Waters Treaty of 1909. However, it is connected to, and flows into Lake Huron and downstream, thus affecting the rest of the Great Lakes-St. Lawrence River System. The present diversion rate of 3,200 cfs causes reductions in the flows in the Niagara River by 1.5 percent, and in the St. Lawrence River by 1.3 percent.

The 3,200 cfs is equivalent to 7.8 billion litres per day, or 1.7 billion imperial gallons per day.
