MEASURES TO PREVENT CLOSING OF SHOE MANUFACTURERS— MOTION UNDER S.O. 43

Mr. Léonel Beaudoin (Richmond): Mr. Speaker, pursuant to the provisions of Standing Order 43, I ask for the unanimous consent of the House to move a motion requesting immediate action as regards the shoe industry in Canada.

Considering that the Anti-dumping Tribunal which is now examining the situation of this industry in Canada agreed to present an interim report next week on a specific category of shoes and considering the urgency for all shoe manufacturers to know the specific steps that will be taken by the Department of Industry, Trade and Commerce in this very important sector and considering finally that the complete report of the tribunal will be tabled next fall only, I move, seconded by the hon. member for Villeneuve (Mr. Caouette):

That the House urge the ministers responsible for the importation of shoes, namely the Minister of Finance (Mr. Macdonald) and the Minister of Industry, Trade and Commerce (Mr. Chrétien), to ask the Anti-dumping Tribunal to give next week a general idea of government measures to prevent the closing of our Canadian plants.

SUGGESTION PROPER METHOD OF MINISTERIAL ACCOUNTABILITY BE DEVELOPED—MOTION UNDER S.O. 43
