BELL ISLAND, NFLD.—REPORTED LAY-OFFS AT ORE MINES

In view of the announcement of a major lay-off and an eight week shutdown period at Wabana iron ore mines at Bell island, Newfoundland, the community's only industry, may I ask the minister whether the government intends to take any action in this regard?

I think the question probably originated from the fact that on April 30 our department completed a piece of work on behalf of the Department of Transport which had been employing 25 men.

REPORTED LAY-OFFS AT POINT EDWARD NAVAL BASE

Hon. Lucien Cardin (Associate Minister of National Defence): Mr. Speaker, on Friday last the hon. member for Cape Breton South asked a question, which I took as notice, with regard to the lay-off of civilian employees at Point Edward naval base at Sydney.

I am informed that a reduction in the refit work load necessitated the lay-off of nine casual ship repair labourers effective May 3, 1963. A release list was prepared in accordance with the department's standard point system, based on seniority, efficiency and veterans' preference.

The possibility of re-employing these personnel with other service establishments and government departments in the area is being investigated.

Mr. Donald MacInnis (Cape Breton South): As a supplementary question following the minister's answer, would the minister care to indicate what other areas in that particular region he has in mind for re-employment of these personnel?

Mr. Cardin: I understand there are other departments in the area where these people might be employed.
