## FEDERAL GRANTS TO PROVINCES

Question No. 289-Mr. Harding:

- 1. What was the total amount paid, or estimated to be paid, by the Government of Canada to the provinces for both unconditional grants and conditional grants for (a) the fiscal year 1967-68 (b) the fiscal year 1968-69?
- 2. What was the specific or estimated amount paid to each of the provinces by the Government of Canada for each category under the unconditional grants for (a) the fiscal year 1967-68 (b) the fiscal year 1968-69?

Hon. E. J. Benson (Minister of Finance): 1. The total amounts paid, or estimated to be paid, by the government of Canada to the provinces for both unconditional and conditional grants for the fiscal years 1967-68 and 1968-69 are as follows: (a) 1967-68, \$2,258,301,000; (b) 1968-69, \$2,454,057,000.

Not included in these totals is the tax abatement portion of the post-secondary fiscal transfer. In 1967-68, the value of the tax abatement was \$227,613,000. In 1968-69, the value of the tax abatement is estimated at \$252,941,000.
