RECONSIDERATION OF CANCELLATION OF GRANT TO NATIONAL CANCER INSTITUTE

It relates to a question I asked the Minister of National Health and Welfare about three weeks ago concerning the cancelling of grants for cancer research. At that time the minister indicated he would reconsider this. Can the Prime Minister inform the House whether these grants for cancer research in Canada have been reinstituted? It seems inexcusable that they should have been cancelled.

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I am sure the minister lived up to his commitment. I do not know the result of that reconsideration. Perhaps the hon. member can ask the minister that question when he returns from the meeting he is presently attending with the provincial health ministers.

CANADA-U.S. AUTO PACT NEGOTIATIONS—SUGGESTED CANADIAN PRODUCTION OF CARS PURCHASED IN CANADA

Mr. Edward Broadbent (Oshawa-Whitby): My question is for the Minister of Industry, Trade and Commerce. In view of the fact that, if Canadians were producing in Canada that percentage of North American automobile products that they actually consume, such production would provide about 30,000 additional Canadian jobs, can

the minister inform the House if in discussions with the Americans his officials have made a request for a change in the auto pact which would bring this about?

Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce): Mr. Speaker, it would take half an hour to deal with the question raised by the hon. member. I hope to do so in due course. In the meantime, I might say that I have already given an answer to that question a few months ago. I suggested at the time it would not be wise to tie ourselves to this particular target. I will make the necessary analysis in the House in due course. I have said on a number of occasions that I will take the House into my confidence before we reach any final agreement with the United States.

Mr. Broadbent: Can the minister inform the House if the state of negotiations on this subject is such that he expects an agreement to be reached before the Christmas recess and, if so, what form of announcement he plans to make in the House? Will it simply take the form of an announcement or is it the intention to have a debate on the issue?

**Mr. Pepin:** Presumably, Mr. Speaker, I will make a statement. My hon. friend will have a chance to reply, comment and disagree with me, I am almost sure.
