EXPORT DEVELOPMENT CORPORATION—INTEREST RATE Question No. 2,691—Mr. Stevens:

In July and August, what was the average rate of interest charged on new long term financing commitments by the Export Development Corporation?

Mr. Herb Breau (Parliamentary Secretary to Minister of Industry, Trade and Commerce): Export Development Corporation states: It is not in the public interest to publish information on EDC lending rates. These rates vary according to such factors as the need to match international competition and the credit risks involved. To publish an average rate would be to disclose to certain borrowers that the EDC rate to them is above the average and this would militate against the possibility of repeat business for Canadian exporters.

BANDARANAIKE AIRPORT, COLUMBO, SRI LANKA

- 1. What has been the total cost to date of the design and construction of the Bandaranaike (Katunayake) Airport at Columbo, Sri Lanka and, of this (a) what amount of the total cost to date was financed by Canadian aid (b) did this aid take the form of a loan or of a grant?
- 2. When was the Bandaranaike Airport completed, or, if the project is still underway, what is the projected date of completion?
- 3. At the conclusion of pre-construction studies, what was the total estimated cost of the Bandaranaike Airport?
- 4. What were the dates of (a) the start of the feasibility study on the Bandaranaike project (b) the start of the construction of the Airport?
- 5. What was the cost of the professional services provided on the design and construction of the Bandaranaike project, including (a) consultant's costs (b) architect's fees (c) engineer's fees (d) project manager's fees (e) lawyer's fees (f) other professional fees and, in each case, what were the names and addresses of each concern retained to perform the work together with the total amount paid or payable to such concern?
- 6. How many scheduled flights were recorded at the Airport during 1972 and in each quarter to date in 1973?
- 7. Based upon the feasibility study report on the construction of the Bandaranaike Airport, what is the nature of the anticipated impact that the Airport is expected to have on the economy of Sri Lanka?

Hon. Mitchell Sharp (Secretary of State for External Affairs): 1. Total cost of design and construction of the Bandaranaike Airport at Colombo was approximately \$7.8 million and of this \$6,568,718.25 was financed by the Canadian International Development Agency as follows: \$5,068,718.25 from Grant Funds; and \$1,500,000.00 from Loan Funds; \$6,568,718.25 Total.

2. The Bandaranaike airport was completed in June 1968.
