RATE OF REAL GROWTH

Mr. Sinclair Stevens (York-Simcoe): Mr. Speaker, in the absence of the Minister of Finance, perhaps I can put my question to the right hon. Prime Minister. As the disappointing real growth figures published by Statistics Canada this morning indicate that real growth in the first quarter of this year was only 0.7 per cent or, on an annualized basis, 2.8 per cent, would he indicate if it is still the government's view, as the Minister of Finance stated in the House last Monday, that real growth for the entire year will be close to 5 per cent? If it is still the government's view, it will mean we will have to reach a 7.6 per cent annualized real growth in the balance of this year, the nine months remaining.

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, the Minister of Finance will be here in a few minutes. Cabinet finished just before two o'clock and he will be in the House shortly.
