In order to equate with the same population selected to answer questions 2,656, 2,657, 2,658 and 2,684 of May 26, 1977 the following substitutions have been made: ES 5 for ES 2; ES 6 for ES 3; ES 7 for ES 4; ES 8 for ES 5. Due to the conversion, and the delays in reporting changes in the information system, the data reported might be at variance with the actual number of employees presently employed within each level.
