(b) The Interdepartmental Committee on Taxation of Northern Benefits held formal meetings on December 11, 1981, January 5, 1982, March 22, 1982 and April 29, 1982. Between the second, third and fourth meetings, there were a number of informal meetings on the topic of the taxation of northern benefits involving, for the most part, committee officials from the Departments of Indian Affairs and Northern Development and Energy, Mines and Resources. On May 4, 1982, a meeting of assistant deputy ministers from the departments represented on the committee was held to review and evaluate the work of the committee, which subsequently met again on May 26.
