They don't want to talk, but I would like to hear what they have to say about this bill. I was really affected when people talked to me about that.

We have today the member for Lévis, who is beside me, Madam Speaker—

**Mr. Lapierre:** There was nothing at all.

**Mr. Della Noce:** The hon. member says that there was nothing. There are four to six million hours of work in his riding. For them, it's nothing. I can also tell you that the opposition to this project comes from one place only, and it is the place that will benefit the most from the economic impact of this project. That place is Quebec, and the opposition comes from the Bloc Québécois. Of course we would like Laval to benefit from the fallout instead of Quebec, but unfortunately we don't have any company that works in that field. We are very happy anyway that the Quebec area will benefit, whether it be Lévis or Richelieu.

My colleague opposite says that there is nothing at all. Maybe we will try to give some figures in a few moments. I mentioned earlier the names of the two corporations from Quebec, Madam Speaker, but I will repeat: Monenco and SNC. The latter was saying to its employees a month ago to do something about the empty spaces. Empty spaces will have to be rented. The Chair said immediately after that the contract—

Motion No. 3

That Bill C-44 be amended by adding immediately after line 27 at page 13 the following new clause:

"23.(1) The Minister shall each year prepare a report with respect to the Hibernia Development Project during the preceding calendar year and shall lay it before Parliament on any of the first fifteen days that either House of Parliament is sitting after he completes it;

(2) The report prepared pursuant to subsection (1) shall indicate

(a) the net direct and indirect economic benefits in each Canadian province which result from the Hibernia Development Project;

(b) the net employment benefits in each Canadian province which result from the Hibernia Development Project, including an analysis of job classifications and salary levels;

(c) the quantities and percentage of oil production which are exported in un-refined or semi-refined states."
