PROCLAMATIONS

HIS Excellency Sir JAMES KEMPT, Lieutenant-Governor, having, by his four Proclamations, dated the 11th April, 11th June, 26th September, and 11th December, 1826, (hereunto annexed) dissolved the last General Assembly, and called a new one; and appointed the same to meet and sit at Halifax this day—being the first day of February, in the year 1827; the following are the names of the Members returned by the Sheriffs of the several Counties, within this Province, to represent the same in the said General Assembly, summoned to meet as before mentioned, viz:
