Parole King of the Turf.

The Course Thronged with Excited
Spectators—near the Congress at
the Baltimore Races.

From the New York World.

BALTIMORE, Oct. 25.—Out to Pim-
lico by way of Madison avenue and
Druid Hill Park is a pleasant ride in
spite of the cobble-stone pavements.

The big trees in the park are gorgeous in
the deep reds, russets, oranges
and yellows of autumn; dead leaves
float like sparks, or flakes of gold,
down through the still, sunny air,
which is just ice-cold enough to be
invigorating, and troops of children
and graceful young girls are out
gathering them.

The track is of the usual oval
shape, with stretches rather shorter
than is customary. There is a fine
two-story clubhouse at the first
turn, and opposite the judges' stand
a couple of public stands, mostly
composed of flights of stairs. In
the inner field, for some hundreds of
feet on either side of the winning
post, are drawn up against the rails
the carriages of members and visit-
ors; the horses removed, each vehicle
is converted into a private box, where
the beautiful daughters of Baltimore
receive the homage of their cavaliers,
watch the races or lunch, extremely
natural, comfortable and at their
ease.

The track is crowded to-day.
People in carriages, mounted or
afoot have long been pouring to the
gates in such throngs and so eager
that the names of the horses and
their owners are scarcely heard above
the shouts of the crowd and the
sneezing of the horses.

There is a buzz of conversation on
all sides though no noise, and fifty
per cent. of the conversation is made
up of the names of the horses and
to run to-day for the American Cham-
pionship.

But they are over and the track is
cleared and every one takes a deep
breath and settles himself or herself
for the day's amusements—all but
the betting men, to whom the horses
are only counters in a game. They
crowd round the pool stand as if it
were a savings bank on which a lively
run was in progress, and when at the
last moment operations are suspended
there is a long queue of gamblers
standing would-be buyers, and a small
forest of arms with greenbacks for
foilage is despairingly agitated.

Ten Broeck, the mighty victor
over the scythe-bearer, is the first
horse out, and shrouded in blackness
he is looked like the mummy of a
pet charger of a Pharaoh. He first
gallops a couple of miles slowly to
"open his pipes," and by that time
the other horses are stripped for the
fray.

With business-like prompt-
ness the boys, in their gay silks,
have been weighed and given a leg
up, and in a few moments the three
meet in front of the stand. Ten
Broeck canters past, a big bay who
does not look so big as he is and goes
faster than he seems to be going, as
quiet as a thoroughbred horse should
be and with a business-like carriage
of the out-stretched neck, a horse
who recognizes that he is called upon
to run, and to do nothing else.

His head is low, his ears are set
back, and he is sweeping by with
head and tail up, looks a much
bigger horse, though the difference
between him and the rest is not really
great. He looks eager, and tosses
his head from side to side as if re-
cognizing familiar landmarks on the
course, and saying, "Here I left
Stamper for the Cup. By the tree
over there I saw him in that infer-
