1. Is Mr. Adjutor Savard in the employ of the dominion government as French publicist for the war savings campaign?

2. If so, how much is he being paid for his services?

Mr. ILSLEY:

1. No. (However, it is understood that he is employed by the Canadian publishers' war finance committee. This committee, which is similar in function to those committees which played an important part during the war loan campaigns of the last war, was set up by Canadian publishers to assist the Minister of Finance in connection with the advertising and publicity aspects of the war savings campaign. A voluntary offer of the publishers to provide this type of cooperation in Canada's war effort was accepted by the minister but responsibility for the organization rests solely on the publishers themselves. The government has had no voice in the selection of the committee or its sub-committees or its employees but has agreed to recoup the committee for its out-of-pocket expenses.)
