## REDUCTION IN PAY AND ALLOWANCES FOR SEA CADET OFFICERS

On the orders of the day:

**Hon. Lucien Cardin (Associate Minister of National Defence):** Mr. Speaker, last Friday the hon. member for Saint John-Albert asked a question with regard to the reduction in rates of pay and allowances for sea cadet officers. I am now in a position to give the hon. member the following information.

As part of the over-all reduction of defence expenditures, and to bring the pay and allowances received by sea cadet officers in line with the reduced amounts available to Royal Canadian Navy reserve active list officers, the number of days pay and allowances that a sea cadet officer may receive for the performance of divisional drills has been reduced

In view of the importance of the matter and of public reports, can the Minister of Justice confirm whether a constitutional conference is going to be held in Canada later this year? If so, where and when, who will participate, and what will be the agenda of such a conference?

## AGRICULTURE

## REPORTED SHORTAGE OF LABOUR ON FARMS

On the orders of the day:

**Mr. P. B. Rynard (Simcoe East):** Mr. Speaker, I should like to ask the Minister of Agriculture whether he is aware of an acute labour shortage in agriculture, particularly on beef and dairy farms?

**Hon. Harry W. Hays (Minister of Agriculture):** Of course, Mr. Speaker, I am aware of the situation. We have been doing some studies recently and have found that over the last 10 years we have been losing about 3 per cent of our farm labour force each year, and we are now down to about 600,000. We are considering this very serious problem. I cannot say anything further than that at the moment, but we do recognize that this is a serious problem.

**Mr. Raymond Langlois (Megantic):** A supplementary question to the Minister of Agriculture. I asked him the other day whether he had any intention of setting up the standing committee on agriculture soon. Is the minister ready today to give us a date as to when that committee will be operating?

**Mr. Hays:** I can only assure the hon. member again that it will be very soon.
