**HARBOURS****COME-BY-CHANCE—PROVISION OF DOCKING FACILITIES FOR OIL REFINERY OPERATIONS**

**Mr. Walter C. Carter (St. John's West):** Mr. Speaker, my question is directed to the Minister of Public Works. In his absence, on February 13 I asked the Minister of Finance whether a feasibility study had been conducted into the Come-By-Chance oil refinery operation. I ask the Minister of Public Works whether the application by the company for a substantial loan to provide docking facilities was rejected on the basis of a feasibility study and, if not, what was the basis of this refusal?

**Hon. Arthur Laing (Minister of Public Works):** Mr. Speaker, I think further representations have now been made by the private company and are currently being discussed by us.

**Mr. Macdonald (Rosedale):** Mr. Speaker, with regard to your previous remarks, it was in the interest of getting more time for questions that we arranged to remove some frontbenchers from the House under the roster system. With regard to the hon. member's question about the business for today and tomorrow—
