DUMPING OF MINE TAILINGS, RUPERT INLET

COMBINES AND ANTI-TRUST LEGISLATION

Motion No. 2—Mr. Salzman:

That an Order of the House do issue for copies of all reports and studies undertaken for the Economic Council of Canada review of Canada's Combines and Anti-trust legislation.

Mr. J. E. Walker (Parliamentary Secretary to Prime Minister): Mr. Speaker, I am informed by the Economic Council of Canada as follows: The review referred to was the second of a series of reports under a general reference from the government on competition policy in Canada. An additional interim report and a final report are still in progress.

It is the policy of the council to make available to the public as much as possible of the analysis underpinning all its work. In this regard the council is currently putting several research studies into a form suitable for publication within the next year and the publication of other studies at a later date is under consideration. I would therefore ask, Mr. Speaker, that this motion be withdrawn.
