HEALTH AND WELFARE

RELATIONSHIP OF BIRTH CONTROL PILL TO SUICIDES AMONG WOMEN

Mr. P. B. Rynard (Simcoe North): My question is to the Minister of National Health and Welfare. In view of the alarming statement made by a medical researcher in the city of Toronto that the birth control pill may be responsible for a 100 per cent increase in suicides among women, is the minister aware of this and what steps are being taken to combat it?

Hon. John C. Munro (Minister of National Health and Welfare): Mr. Speaker, I think the hon. member is referring to a study by Dr. Anderson comparing the suicide rate last year with the year 1959-60. The doctor stated this could not necessarily be connected to oral contraceptives. At the same time he pointed out that because of the use of oral contraceptives by women there is a considerable reduction in the number of deaths. This is because of pregnancies not occurring and the ill effects of premature childbirths.

Mr. Rynard: A supplementary question. I asked the minister if he is aware of this statement and if he is going to take steps to see that further studies are made?

Mr. Munro: The findings of this doctor were made known to the special committee advising me on this whole subject prior to his releasing it in the medical journal. We are studying the whole matter very seriously. The data which he used to found his conclusions will all be taken into consideration. The final report will probably be ready in four or five weeks.
