sumer. In addition, each consumer receives general information about consumer rights and company obligations within the contractual warranties. In the case of the Ford Motors Company, consumers are provided with details of the company's policy on post-warranty adjustments relating to automobile corrosion.

- 3. The association provided copies of internal documents from two Canadian and one United States companies. These documents were sent or given to the Department on March 21 and November 5, 1975.
 - 4. Yes: see also the answer to question (2).
- 5. Initially two officers were assigned responsibility for the Department's work on the problem area. They were chosen for their experience in handling automobile complaints, and in problem analysis and policy development. Before the remainder of the Unit could be staffed with officers having appropriate experience and expertise in the automotive field, the companies refused to co-operate with the Minister by providing documents which could be released to the public. At the present time, apart from handling automotive complaints and enquiries, policy is being developed in the more general area of warranties and guarantees.

6. Yes.

7. The result of an inquiry by the Director of Investigation and Research under the Combines Investigation Act into claims made by S.T.P. for their gas treatment product resulted in the referral of a Summary Evidence to the Attorney General of Canada on January 30, 1974. After careful and extensive consideration of the matter and in view of the fact that the company had discontinued the use of the performance claim which had given rise to the inquiry the matter did not result in a charge being laid. Since the revision of the company's advertising, the Department has received no further complaints.

JACQUES CARTIER TERMINAL—PORT OF MONTREAL

Question No. 5,103—Mr. Forrestall:

- 1. What is the estimated completion date for the Jacques Cartier terminal now under construction at the Port of Montreal?
- 2. What is the estimated total capital cost of the facility including the amount allocated for the take-over of existing break bulk facilities to be incorporated as part of the terminal?
- 3. Have any commitments been made by shipping lines and/or terminal operating companies to use the terminal and, if so, which shipping lines and/or terminal operating companies?
- Mr. Ralph E. Goodale (Parliamentary Secretary to Minister of Transport): The National Harbours Board advises as follows. 1. The estimated completion date is April 1977.
- 2. The estimated total capital cost, including the amount allotted for the takeover of existing break bulk facilities to be incorporated as part of the terminal, is \$5,500,000 exclusive of portainers for which a lease is still under consideration.
- 3. It is planned to operate the Jacques Cartier Terminal as a public facility and no contract has been concluded with any terminal operators or shipping lines.
