trail. Unfortunately, the Government of Nova Scotia, aided and abetted by the federal Government, has done absolutely nothing.

We have called upon the Deputy Prime Minister (Mr. Mazankowski) to consider the possibility of providing moneys under the Federal-Nova Scotia Agreement on Highway Strengthening. Unfortunately, the Deputy Prime Minister (Mr. Mazankowski) and the Minister of Transportation in the Province of Nova Scotia have turned thumbs down to thousands of Canadians in that particular region of our country seeking assistance to build an extension to the Fleur de Lis Trail.

I call upon the federal Government to reverse this negative decision and to come through with some positive contributions in order to increase tourism opportunities in industrial Cape Breton.

IMPORTANCE TO ECONOMY OF CAPE BRETON—ASSISTANCE FOR LAND OWNERS ADVOCATED

Mr. Lawrence I. O'Neil (Cape Breton Highlands—Canso): Mr. Speaker, in my riding the forest industry is critical to our long-term economic health, to the maintenance of jobs, and to the creation of new employment. Forest management practices are therefore of utmost concern to me.

In Nova Scotia approximately 75 per cent of the land is owned privately. This contrasts with the situation in other provinces where most land is Crown owned.

To address the management needs of private wood-lot owners, the Government of Canada is funding forest group ventures. The province is also a sponsor. These are co-operatives formed by wood-lot owners. Land owners receive financial help to administer land management programs and to cover the cost of the silviculture work itself.

Today I want to recommend to the Minister of State for Forestry and Mines (Mr. Merrithew) that a group venture application to be submitted by more than 80 Antigonish County land owners receive early approval.

This group is aggressive and responsible and knows from first-hand experience the benefits of good forest management.

Since my election, four such ventures have been established in my riding. I look forward to announcing funding for this group as well. S. O. 21
