

FINAL FIGHT FOR RIDING

 folk County was to lose a member. It was impossible, he said, to devise a redistribution that would be satisfactory to all parties. The government, by ignoring county boundaries could have deprived the Conservatives of a great show in the vicinity of Norfolk. Having delivered himself of this heavy argument in defence of the bill, John Charlton described the gerrymandering of 1882 as political assassination, perpetrated regardless of honesty and justice. The redistribution bill of 1893, on the other hand, was moderate, honest and just.
 John Haggart said some hard things about the redistribution bill. He denounced the redistribution and holly-conjured his creators.
 Mr. Haggart then moved an amendment to the effect that the bill should be sent back to the committee, and the schedule attached in accordance with the principles laid down in the motion made by Mr. Horden before the Redistribution Committee.
Herman to the Rescue.
 From C. Hyman came a stout defence of the work of the committee and an indignant repudiation of the motives which had been imputed to it. This member for London defended the bill first on general grounds and then in detail. He would not admit that an injustice had been committed in a single instance. After a long discussion, the house divided on Mr. Haggart's amendment. The amendment was lost.
Herman to the Rescue.
 From C. Hyman came a stout defence of the work of the committee and an indignant repudiation of the motives which had been imputed to it. This member for London defended the bill first on general grounds and then in detail. He would not admit that an injustice had been committed in a single instance. After a long discussion, the house divided on Mr. Haggart's amendment. The amendment was lost.
Amendments Lost.
 In reopening A. LeFurguey of East Prince Edward made an appeal on behalf of his province. Mr. Hackett's amendment was then declared lost. Mr. LeFurguey moved an amendment providing for a re-arrangement of the boundaries of the four Prince Edward Island constituencies. This amendment was also lost.
 E. F. Clarke moved an amendment in which he asked for increased representation for the County of York, including Toronto, and the County of Middlesex, including London.
 He quoted figures to show that York County and Toronto have been harshly dealt with in comparison with other constituencies. Toronto, with one-fourth of the population of Ontario, had only one-seventeenth of the representation. Toronto also had one-seventh of the assessment of the province. Archie Campbell moved that the City of Toronto was being fairly treated. In 1891 the unit of representation was 11,000, now it is 42,000.
 E. B. Oiler declared that if there was any reason for increasing the representation in Toronto it was that there was just as much reason why the unit of representation should be increased in East York and West York. It was not fair that the unit of representation in Toronto should be double that of any other constituency. Mr. Hyman regretted that York County and Middlesex County should be grouped in the amendment. He insisted that Toronto has received all justice at the hands of the committee, especially in the light of what the redistribution of 1891 had done for the city.
 The amendment was finally lost. Dr. Roche of Marquette followed, moving Mr. Horden's committee proposition regarding the re-arrangement of the constituencies. George Taylor moved that Leslie and Grenville should have three members. Mr. Horden proposed that Cape Breton County by itself should have two members. Mr. Clancy moved the

These were all voted down, and at 12 o'clock the measure passed its third reading.
Dropped a Bill.
 Mr. Fisher's bill regarding the inspection of seeds was dropped.
 Mr. Taylor pressed for an adjournment, which was reluctantly acceded to by Sir William Mulock. He would have preferred a little more progress to be made. E. F. Clarke alluded to the disgraceful treatment accorded by American customs officials at Newport to two British delegates on their way home after attending the Congress of Chambers of Commerce of the empire in Montreal, and he suggested that the Canadian government should make representations to the United States authorities to prevent a recurrence of a like difficulty.
 Mr. Fielding was not sure that anything could be done on our part, however much the government might regret the incident. However they would require.
 In view of the Transcontinental Railway bill being printed in its new form, the House on Monday will take up the bill regarding civil service salaries and other minor items on the paper with possibly some items of supply.

LONG FIGHT ENDED.
 Ogdensburg, N.Y., Sept. 25.—The long fight of the Brockville, Westport and Sault Ste. Marie Railroad has ended, and the title of the New York Legislature has been conferred by an Act incorporating the Brockville, Westport and Northwestern Railway Company, to operate a road from the Thousand Islands to the Upper Lakes, with a bridge over the St. Lawrence River at Brockville. Construction and equipment of the old company, whose claims amount to about \$200,000, will receive 25 per cent. of their original claims, while the amount actually received and earned by the new company. All actions to set aside the sale are dismissed.
