THE HAMILTON & NORTH-WESTERN RAILWAY it is proposed will enter the County at Ballycroy, thence, to Tecumseth and through to Alliston, crossing Tossorontio to Poda Mills, entering Nottawasaga at the south-east corner via Avening, Creemore and Duntroon to Collingwood.

LUMBER.

The County of Simcoe has long been celebrated for its extensive lumbering establishments.
