(b) D123724 Pte. BUREAU, A. was on the 16th October, 1942 awarded:--28 days detention. For:--Absent without leave from 1630 hrs., 24-9-42 to 1200 hrs., 27-9-42. (Absent 2 days, 19 hrs., 30 mins.) Forfeits 3 days' pay under F.R. & I. for the C.A. 149(a). Held in close arrest from 1200 hrs., 27-9-42 to 2400 hrs., 15-10-42. Total forfeiture of 50 days' pay.

(c) H45611 Pte. DODD, W. was on the 17th October, 1942 awarded:--28 days' detention. For:--Absent without leave from 0800 hrs., 23-9-42 until apprehended at St. John, N.D. at 1600 hrs., 11-10-42. (Absent 18 days, 8 hrs.). Forfeits 19 days' pay under F.R. & I. for the C.A. 149(a). Held in close arrest from 1600 hrs., 11-10-42 to 2400 hrs., 16-10-42. Total forfeiture of 52 days' pay. To pay costs of apprehension and return to unit in the amount of \$21.30. (Transportation for escort--\$14.20)(Transportation for prisoner--\$7.10)

Total forfeiture of 16 days' pay and 6 days' allowances.

(Absent 18 days, 7 hrs., 45 mins.) Forfeits 19 days' pay under F.R. & I. for the C.A. 149(a). Held in close arrest from 1545 hrs., 11-10-42 to 2400 hrs., 16-10-42. Total forfeiture of 52 days' pay. To pay costs of apprehension in the amount of \$21.30. (Transportation for escort--\$14.20)(Transportation for prisoner--\$7.10).
