

## More quorum difficulties

A scheduled meeting of the water management advisory board of the Credit Valley Conservation Authority was cancelled this week because of a lack of a quorum.

The meeting was to be held last Wednesday afternoon at 4 p.m., but only three of the 10 members of the committee indicated they could make the meeting. They were committee chairman Ken Whillans, the authority chairman, Grant Clarkson, and citizen member Hubert Wolf.

City Councillors Mary Helen Spence, Larry Taylor and Harold Kennedy were scheduled for all-day meetings at city hall. City Engineer William Taylor, who is also a board member, was also involved in those meetings.

The citizen members who could not make the session were Blake Goodings, Jack Jones, and Richard Martin.

The committee has experienced some difficulty in getting a quorum recently and held one meeting without one.

The Wednesday scheduling conflicts with Mississauga councillors' calendars. Shortly after it was decided to hold water management board

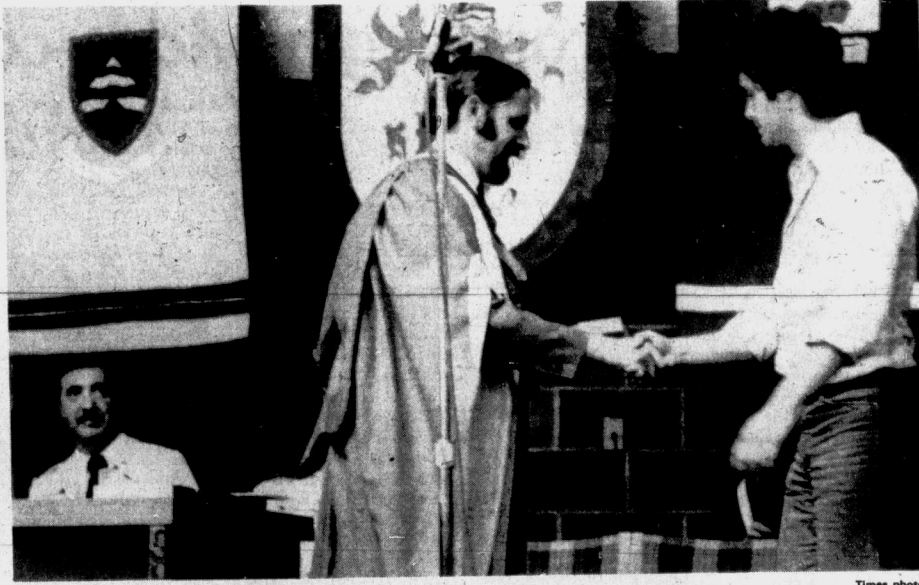
meetings Wednesday afternoons, the city decided to reserve all day each Wednesday for general committee.

At the full authority meeting Thursday night, Whillans was highly critical of city councillors for lack of attendance. He and Spence were involved in a sharp conflict over the issue.

At one point Whillans said he would consider asking for Mrs. Spence's resignation because of poor attendance.

The Ward 2 Councillor suggested Whillans set the meetings on a day when it is convenient for city members to attend.

She said the authority had been told "at least a dozen times" that Wednesday sessions present problems for Mississauga representatives.

## Authority backs Mullett proposal

The proposals by developers Cadillac-Fairview Corporation and Markborough Properties to channelize part of the Mullett Creek has been approved in principle by the conservation authority.

The move came despite argument from some Credit Valley Conservation Authority members that the proposal should be referred to the city's engineering department first.

Councillor Frank Leavers of Mississauga and Brampton's Ken Whillans wanted the plan referred to City Engineer William Taylor.

Under the proposal by authority staff, part of the creek would be channelized from Highway 401

south to the Mullett Creek diversion near Erin Mills Parkway. A small portion of the west bank would also be channelized, but staff wants to preserve the scenic upstream portion of the west branch. This area is designated as an Environmental Protection Area in the city's draft Official Plan, meaning there

should be no development in it.

Ward 2 Councillor Mary Helen Spence felt the authority should approve staff recommendations in principle before sending them to city staff for review.

The day after the meeting, Mrs. Spence explained that she felt it was "very important that the city engineering department not take over the work of the conservation authority."

### STRAWBERRY SOCIAL

Lakeview United Church will hold a Strawberry Social Dinner, 1023 Greaves Ave., on June 29 from 5:30 p.m. to 7 p.m. There will be door prizes and lots to eat. Admission is \$4 for adults and \$2 for children 6 to 12. Children under six are admitted free.

There have been some conflicts surface recently between the conservation authority staff and city engineering staff. The city has claimed that some proposals by the authority to maximize conservation safeguard are not manageable in proposed subdivisions.

CVCA Chairman Grant Clarkson supported approval in principle of the Mullett Creek proposals. The authority agreed to endorse the staff recommendations in principle and refer the matter to Mississauga staff for comment.

### NEW FAIR DATE

Britannia Fair, which got rained out last Saturday, is rescheduled for this Saturday. Location is Britannia School House on Highway 10, just north of Eglinton Avenue. It will open with a bake sale at 11 a.m., followed by a country auction, 1 p.m. New and used items will be featured. There are snacks, plant tables, crafts, fish pond, pony rides, used clothing and a bake sale. All welcome.

## Creek change approved

The Carolyn Creek realignment to facilitate the proposed sanitary landfill site in central Mississauga has been approved in principle by the Credit Valley Conservation Authority.

At its meeting Thursday night in Caledon East, the authority agreed with recommendations in the engineering report by the consulting firm of Proctor and Redfern. They prepared the engineering study of the site for Peel Region.

After a recent Environmental Hearing Board session on the proposed location, the region is awaiting approval of the site at Second Line West and Britannia Road.

Although the authority gave approval in principle this week, the detailed engineering proposals to realign Carolyn Creek will be submitted to staff and reviewed by the authority's executive committee before any final endorsement.

**NOTICE OF APPLICATION to The Ontario Municipal Board by The Corporation of the City of Mississauga for approval of a by-law to regulate land use passed pursuant to Section 35 of The Planning Act.**

TAKE NOTICE that the Council of the Corporation of the City of Mississauga intends to apply to The Ontario Municipal Board pursuant to the provisions of Section 35 of The Planning Act for approval of By-law 278-77, passed on the 25th day of May, 1977. A copy of the by-law is furnished herewith. A note giving an explanation of the purpose and effect of the by-law and stating the lands affected thereby is also furnished herewith.

Any person interested may, within fourteen (14) days after the date of this notice, send by registered mail or deliver to the clerk of the City of Mississauga notice of his objection to approval of the said by-law, together with a statement of the grounds of such objection.

Any person wishing to support the application for approval of the by-law may within fourteen (14) days after the date of this notice send by registered mail or deliver to the clerk of the City of Mississauga notice of his support of approval of the said by-law together with a request for notice of any hearing that may be held giving also the name and address to which such notice should be given.

The Ontario Municipal Board may approve of the said by-law but before doing so it may appoint a time and place when any objection to the by-law will be considered. Notice of any hearing that may be held will be given only to persons who have filed an objection or notice of support and who have left with or delivered to the clerk undersigned, the address to which notice of hearing is to be sent.

**THE CORPORATION OF THE CITY OF MISSISSAUGA  
BY-LAW NUMBER 278-77  
A By-law to amend By-law Number 5500 as amended.**

THE COUNCIL of the Corporation of the City of Mississauga pursuant to Section 35 of The Planning Act, R.S.O. 1970, and amendments thereto, ENACTS as follows:

By-law Number 5500 as amended, being a City of Mississauga Zoning By-law, is hereby further amended as follows:

1. By adding subsection (1a) to Section 110, thereof, which shall read as follows:  
(1a) Notwithstanding clause (c) of Section 109 herein, no person may use land or erect or use any building or structure in an 'M1' Zone for the purposes of a restaurant.
