All the Property and Effects, real, or personal, of what nature, or The property kind, soever, now belonging to, or vested in, the Corporation of the Chan- of the sai cellor, Masters and Scholars of the University of Toronto, or in the Cor- to be vested in the Crown poration of the Principal, Masters and Scholars of Upper Canada College and for the Royal Grammar School, or in any Person, or Persons, body, or bodies, politic, purposes of or corporate, in trust for the said Corporations, or either of them, shall, from and after the coming into force of this Act, be, and the same, and every part thereof, are hereby transferred to and vested in Her Majesty, Her Heirs and Successors, for the purposes of this Act, and shall, as shall also all Deeds, Titles, Accounts, Books, Maps, Plans, Documents and Writings belonging to, or relating to the same, be forthwith delivered up by any Person, or Persons, Officer, or Officers, as the Governor of this Province shall appoint, or authorize, to receive the same; and every Right, Title, Claim, or Demand, of either of the said Corporations to any real, or personal, property, debt. or sum of money, shall be, and is hereby, vested in the Crown; and any suit of proceeding for the recovery thereof may be brought, or continued, by, and in the name of, the Crown, upon suggesting of the passing of this Act; and every debt due by, or claim upon, either of the said Corporations may be paid, or satisfied, by the Crown out of the property transferred, as aforesaid; and all property, real or personal, which shall be hereafter given, devised, or bequeathed, to, or for, the use of either of the said Institutions, or to, or for, the use of [University College] any of the Institutions herein named and provided for, shall be vested in the Crown for the purposes of this Act.
