British American Book and Tract Society.

To the Editor of the Union Advocate.

Sir,—Having just returned from a tour in the interest of the Colportage work of the above Society, I beg leave through your columns to return thanks to the 650 friends that contributed to that object, and to numerous others who spoke kindly of our work and bade us God speed in all our efforts to reach the poor and the despised in our land. Acknowledgment in detail will be made in our Annual Report. In a summary form the collections in P. E. Island are as follows:

Charlottetown, \$178.49; Summerside, \$34.09; Alberton and Montrose, \$34.65; Belvedere, \$30; Montague Bridge, \$20.50; Souris, \$18.10; Montreal, \$12.02; Georgetown and West River, \$13.71, making in all \$348.56 in addition to unpaid subscriptions. Places visited and donations received in New Brunswick as follows:—Shediac, \$13.80; Moncton, \$80.30; Kingston, \$26.80; Richibucto, \$24.40; Chatham, \$23.83; Dalhousie, \$24.21; Newcastle, \$35.50; Bathurst, \$58.70; Dalhousie, \$21.40 and Campbellton, \$45.50. Making a total for New Brunswick including unpaid subscriptions of \$389.75. This shows an increase of \$850 over a similar collection from those places in 1881, for which we are grateful to Him who has moved his people to liberally sustain a work, prominently designed to contribute to His glory.

There are now 10 men employed in Nova Scotia; 2 in New Brunswick; 2 in P. E. Island; 2 in Cape Breton and 2 in Newfoundland. Arrangements are being made for work among the lumbermen of New Brunswick during the winter. It is probable that more than 10,000 men will be made pleasant to them by the perusal of good books and the evangelistic work of our agents. Who will give special donations in aid of this much needed work?

Report from our Colporteurs are on the whole most encouraging. Many places are being visited that have not hitherto been supplied with books. I give a brief extract from the last quarterly report of the Colporteur labouring in Lunenburg County:—"I have been for the last fortnight in some dark places where there are no schools and in several sections no school houses. In one section they were obliged to select a man outside their bounds as secretary since no person in the district could fill the position. Not a slight member of some families in these sections is a word. Many are most indifferent to education and openly hostile to any tax for its support. A few, principally women, deplore this state of things. A mother told me that her little girl's eyes were dimmed, and she told her of a word in her school book. She would spell out the words but neither father nor mother could tell the poor child what the letters meant. In such sections there is great destitution of books and that, too, when the people say that they have "lots of books of all kinds."

Some seem to think that one or two books will suffice and find it difficult to understand that all books are not alike. In September I visited a home in which a poor consumptive girl was fast sinking, and one which death has frequently visited during the past few years. I talked, read a portion of Scripture and prayed with her, and hope she is resting upon Christ the sure foundation. I left one or two small books with her and bade her good-bye, while tears of gratitude fell down her cheeks. On talking with her parents I found that they had only a portion of a small printed Bible, which their eyes dimmed with age was of no service. I gave them a Bible in good type. The father burst into tears, thanked me earnestly for the gift, promised to have a portion of it read

REPLY TO "R. W."

BATHURST, OCT. 14.

To the Editor of the Advocate.

Sir,—In the last issue of the "Advance," a writer under the signature of "R. W." takes umbrage at some items recently furnished your paper by "Duplicate," the Bathurst correspondent.

Permit me to say in reply that the allusions made give evidence either of invincible ignorance of the facts of the case, or hopeless mental imbecility. Referring to Professor Foster as an M. P. P., instead of M. P., was not a serious mistake, and hardly deserving more than passing notice. Notwithstanding "R. "Duplicate" should be instructed by certain editors as to the kind of items he may furnish from time to time for their papers. But the fact of his past connection in a reportorial capacity with the leading journals of St. John and elsewhere should be sufficient proof that he understands catering to the intellectual tastes of a majority of intelligent readers.

An editor who is willing to publish such ineffable rubbish as the "Advance" contributor supplies, invites financial ruin to his otherwise commendable paper. In future, we would suggest that Dr. Steeves of the Fairville Institution be instructed to exercise a closer surveillance over the inmates entrusted to his charge; and that a committee of experts be at once appointed to examine into "R. W.'s" mental condition, as judging by his latest effusion, it is unsafe for the community in which he lives to permit him any longer to roam at large.
