present at least two Conservatives resistant to those who gave him information in preparing the lists, and did not protest against a single name he put on. Mr. Stevenson did not excuse himself before the judges or attempt to do so "by declaring" some lawyer told him "to pursue this course."

Domiciled in Territory.

He said he had taken an oath to make up the lists in accordance with the Ontario lists act, and did so strictly according to the act. He referred to the board to the amendment made in the law by the Ontario Legislature in 1905, when the provision for continuous residence from any date whatever is abolished, and in place of that the Legislature enacted that each voter must be "a resident of and domiciled in the territory for which the list is being prepared."

He said he was before the board of judges it was shown that every man whom Stevenson put on these lists was then actually in the camps, and, further, that every such man was in these camps all last season, and the majority of them for the past two or three seasons and for as many as five or six seasons past. The whole issue is whether the men were "resident of and domiciled" there on August 1st last. Scores of these men were actually in the camps on and before August 1st. Others came later on up to September 12. But each of these had been in the camps till they broke up in the spring, then they went on the river drives, and so soon as the camps reopened in July and August they commenced returning to them for this season's operations.

All of these men are British subjects of full age and resident in Canada previously, in full compliance with the law. The whole question as affects those not there on Aug. 1 is whether the fact of working in these camps last season and former seasons and that their homes are in the unorganized territory entitles them to go on the lists in compliance with the law. The judges are now sitting to determine this, and each voter is brought personally before the judges when his case is being considered.

The people here have every confidence in the judges. When the lists came before the judges at this place for revision it was found that the Conservatives had not subpoenaed the voters in the proper way or in the proper time as required by the Ontario voters' lists act, but had sent subpoenas to the voters by express, and so late a date that the men could not possibly have received the subpoenas before the court of revision sat. No witness fees or travelling money was sent to the men with the subpoenas or paid them, nor had the Conservatives put in a legal appeal against any of the men.

The Liberals objected that the men could not possibly come into the court at the Soo; that they would have to travel one way at least 45 miles, and many of the men one way at least 70 miles. They said that the judges decided to go out to the camps and revise the lists there. As a matter of fact, the whole revision has been conducted by the judges in every way to prevent any wrongdoing and to protect the rights which the Conservative candidate is afraid are being outraged. The facts are known here to the people at large, and there is neither excitement nor fear as to the revision by the judges. The act of Attorney-General Foy is reprobated on every side.

We have had lots of air, hot, cold and dry, but we want it "wet," and as soon as we can get it.

In your report of the commissioners' meeting in last night's Advertiser, the oldest and most experienced commissioner on the board—from whom so much was expected by the people this year—owns up at this late date "that there is more water at Kilworth than he imagined." Now, surely it's not too much to expect that our water commissioners would be past the inauguration stage by this time, but it appears not. This is the 22nd of October, and yet the mayor says "that he was surprised at the amount of water there," and the people are surprised, too, that neither of these gentlemen took the trouble to find out until now that the water was there. Now, Mr. Editor, my reason for taking up so much of your space is this: There are a large number of unemployed at present in the city, and work this winter is going to be scarce for such men as laborers, and if our commissioners could be induced to get a move on, and have as much work as possible done by the waterworks extension during the winter months, they would be giving a number of men much-needed employment, when it would do the most good. Surely, if one member of the school board can give out painting contracts by the wholesale, our water commissioners as a body should be able to devise some scheme to insure us enough water to bathe the children before going to school, so as to keep the paint clean as long as possible and preserve the memory of the gentleman who had it done. report. This was not the man to put in charge of the finances of Canada, he said.

Mr. McEvoy's Address.

Mr. McEvoy delivered a brief but telling speech, criticising Borden and Foster for their fault finding on the immigration policy of the Government. Settlers were needed on the great plains of the west, and if the Government did not select them from the west, bringing in the best that could be obtained, they would come from some other source, the east, as it was inevitable that this land be settled. In eloquent terms he unfolded the possibilities of the west land, from which the paint had not been rubbed. He also effectively replied to the "scandals," showing that the Government dealt fairly and honestly, and had received infinitely more value for the lands than the Conservatives had received.

Mr. J. C. Elliott was in fine form. As a public speaker, he is improving rapidly, and will be a considerable addition to the debating strength of the Ontario House. He dealt particularly with the financial policy of the Government, showing how wise legislation had made the country prosperous.

Many electors drove for miles to attend the meeting. The Mount Brydges male quartette, composed of Messrs. Lipsett, Thompson, Elliott, Dr. McElliott, sang several selections in excellent voice, and added greatly to the pleasure of the occasion. The Calvert quartette, from Strathroy—Messrs. Evans, Rapley, Baskerville and Siedel—contributed to the programme Duets were rendered by Misses Young and Lunley, and excellent violin solos were given by Mr. J. Monteith, of Mount Brydges. Miss Allen Code accompanied the singers.

Mr. Louis Sutor, Glencoe, was the chairman. He was delighted to preside over such an audience, which proved that Liberalism in Glencoe was not dead by any means. There was no stampede in West Middlesex, and on the evening of Oct. 28 it would be seen that this riding was still true to Sir Wilfrid Laurier.

Mr. Geo. Innes, Ekfrid, President of West Middlesex Reform Association, desired to utter a protest, as a farmer, against the use of the former cry in the contest. Mr. Calvert, during his term in the House had shown himself deeply interested in the welfare of the farmers and had done his duty. Farmers did not claim special privileges over any class. Mr. Calvert was the nominee of a farmers' convention just as much as Mr. McLaughlin, and had during his career shown at least as much interest in the farmers as the Conservative nominee. Mr. Innes was convinced that West Middlesex would be true to Liberal traditions and would elect Mr. Calvert by an increased majority.

The speaker defended the immigration policy of the Government, and declared its policy on this matter to be correct. There was still a great need of farmers and farm laborers, and in this the Laurier Government should be allowed to finish its work. He also contrasted the two candidates, and asked the electors to judge of their merits.

J. C. Elliott was given a magnificent reception by his fellow-townsmen. It was many minutes before he could get a hearing. He was more than delighted at the large meeting, as it evidenced most clearly that the stories regarding the defection of the Liberals were unfounded. He was delighted at the manner in which the Liberals in all parts of the riding were rallying to the support of the Government candidate.

"I am delighted to appear before you on behalf of such a candidate as Mr. Calvert," said Mr. Elliott, "and speak on behalf of such a Government as we have. Mr. Calvert has represented the riding for twelve years, and was the best representative in the Dominion House the riding ever had, and he has supported the best Government Canada has ever experienced." Cheers.

Mr. Elliott referred to the dark days of Liberalism in West Middlesex prior to 1896. The riding was so gerrymandered that in spite of excellent candidates it was impossible to dislodge the Conservatives, so strongly were they entrenched, that when a young man, living in Napier, was selected as a candidate two years before the election. He reluctantly accepted, but when the call came he set to work manfully, and by personal canvass, organization, and oversight of the voters' lists, he was able in 1896 to wrench the riding from the Conservatives. Since that time he had represented the riding in the House. His progress had been rapid, and his position as chief Government whip showed the confidence Sir Wilfrid Laurier had in him. At Strathroy the Premier spoke in no uncertain terms of Mr. Calvert's ability.

"Mr. Calvert must be a good man, he is so abused by the Conservative press," commented Mr. Elliott. "He is continually referred to as a chief of funder, and he is pictured as influencing legislation, more than any member of the Government almost. This is a tribute to the man, and shows that he is a large man, and a worthy representative of the Liberal interests."

The speaker then referred to the splendid record of the Laurier Government. Since the tariff had been revised by Hon. Mr. Fielding the trade had increased four times what it was prior to 1896, and every year it was increasing by leaps and bounds.

The Conservatives explain the change by saying that Sir Wilfrid stole Mr. Borden's clothes," said Mr. Elliott. "That can hardly be. Just imagine Sir Wilfrid stealing such clothes. It certainly would not ruin Mr. Borden's clothes, but it certainly would destroy Sir Wilfrid's figure. (Laughter.)

The Conservative party came before the people of Canada with no policy whatever. They offered nothing to the electors, but merely shout graft at the top of their voices. The intention is to draw the minds of the people from the issues of the campaign.

"I am convinced that the Conservatives would like to drop the scandal cry," said Mr. Elliott. "I am positive that Mr. Foster, the power behind the

have not received a dividend for fifty years, and they must be shown some consideration. The railways have plainly told us that if the passenger rates were lowered the freight rates must of necessity be increased. If that were the case it would affect the farmers more than any other class. The farmer does not travel as much as the city man, but he does ship a great deal of produce. If the freight rates were increased he would be compelled to pay much more to get his produce to the market, and the result would be that his position would be worse than before. I am just showing you the difficulties in the way, and demonstrating that it is a big question, one that cannot be settled in a minute. I might also point out that this question is now in the hands of the railway commission, and just as soon as it is thought advisable, the rate will be reduced."

The Candidate.

Mr. W. S. Calvert was given a tremendous ovation on rising. He was presented with a handsome bouquet of roses by pretty Bessie Shaw, who received the customary salutation. He expressed his great pleasure at the ovation tendered him and was delighted to see so many of his friends from Mt. Brydges, Strathroy and other places. It showed the interest the electors of West Middlesex were taking in the campaign, and told him that his friends were rallying to his support all over the riding.

We have been discussing the public questions throughout the riding as I think a candidate should," said Mr. Calvert. "A representative of the party should have a platform, and he should explain that platform to the electors and give them an opportunity to express their opinions on it intelligently. We are not afraid of our policy. It will bear scrutiny, and we are meeting every charge face to face. "We have been charged by our opponents with securing \$18,000 for a new postoffice in Glencoe," said Mr. Calvert. "If that was a crime we plead guilty. We did secure that grant because the people of Glencoe and the surrounding country wanted it. Several petitions came to me, and I did my duty. I am certain that when it is erected it will be a credit to the town. Mr. McLaughlin would divide the post-office into several parts and give other sections of the riding a postoffice, but I can't see how that would help matters. I am sorry it cannot be finished this fall, but it will be ready next spring."

"The Conservative papers also charged that I was afraid to go to Wardsville, so much was public sentiment against me there," continued the speaker. "I want to say that I did go to Wardsville, and we had a splendid meeting. We discussed public questions at considerable length, answered all questions, and met with a most cordial reception. We are not afraid to meet the electors of the riding."

Mr. Calvert referred to Mr. McLaughlin's plea for increased railway taxation and declared that if the Conservative candidate desired to show his real interest in the welfare of the Dominion, he would take the matter up with Sir James Whitney, under whose control this question came.

"No objection to increasing the taxation of the railways; I favor it. But Mr. McLaughlin should not make such a fool of himself by trying to bring the issue into the arena of Dominion politics, as it belongs absolutely to the Provincial Legislature. Let him go to Sir James Whitney, and get the taxation increased. "He also represents me as opposed to the two-cent a mile rate. I am not opposed to it; I favor it. I am the representative of a rural constituency, and from my standpoint the matter should be inquired into carefully. If I were the representative of the city constituency I would move to have fares reduced immediately. You must consider the fact that the stockholders of the Grand Trunk

Oklahoma Crippled by Big Flood

Tulsa, Oklahoma, Oct. 22.—Flood conditions in this vicinity are rapidly growing worse. The Arkansas River is rising a foot an hour. A heavy rainfall in Tulsa and Bartlesville last night crippled oil field operations, and the pump stations of the Prairie Oil and Gas Company are out of commission. All trains are delayed.

The heaviest rainfall experienced in that section in many years began at midnight last night and continued today. The Arkansas and Grand Rivers are rising. The low lands of Muskogee are flooded, and in some sections residents cannot leave their homes without the aid of boats.

At Ed Reno two hundred workmen were unable to reach their work in the Rock Island Railroad shops and at the new yards the day and night crews were compelled to go to their homes in boats, owing to the high water from Four Mile Creek. The ice plant and other industries in the northwest part of the town have been forced to close.

Some Places May Be Disfranchised

Ottawa, Oct. 22.—The Government has no authority to issue any order for the postponement of the Algoma or other elections, and there is no likelihood of the returning officers taking this step so far as anyone at Ottawa has heard. The lists now being revised in Bellevue, Marmont and Trout Lake are not likely to be completed in time to be printed at Ottawa and so there can be no voting in these districts.

Suicides Rather Than Face Trial

New York, Oct. 22.—Rather than face trial for manslaughter, growing out of a case of alleged criminal practice, Dr. Irving J. Cook, a young doctor of this city, drank a dose of poison and shot himself at the Waldorf-Astoria Hotel today. The dead man left a sealed letter, addressed to his wife, but accompanying it was a terse note in which he asked her "not to take this affair hard."

He told her also that he had left her \$447 in cash and directed her attention to the sealed letter. Dr. Cook was to have been prosecuted for the death of a young woman at Summit, N. J., last summer. He was under bail of \$10,000 for trial.

Brantford, Oct. 22.—Harry Summerhays, lineman for the Bell Telephone Company, had a remarkable experience this morning. He was shaving the top off a forty-foot telephone pole in a lane in the rear of College street, using a long knife with handles at both ends. The knife slipped as he stroked it towards him, and the blade severed the leather belt which bound him to the pole. He fell backwards, landing on his back on the roof of a shed in the rear of the Grafton establishment, 25 feet below. This probably saved his life, as had he fallen the full 40 feet to the ground he would have been killed. His back is injured, and it is thought he is also hurt internally, but will recover.
