HAMILTON FALLS—FEDERAL INTERVENTION IN PROVINCIAL DISCUSSIONS

Mr. Andrew Brewin (Greenwood): Mr. Speaker, I have a question for the right hon. Prime Minister of which I sent him notice, but he is not here today and I am not quite sure who I should look at as the Acting Prime Minister when I ask my question.

An hon. Member: Mr. Pickersgill.

Some hon. Members: Oh, oh.

Mr. Brewin: Mr. Speaker, I am sure the Acting Prime Minister will be particularly interested and particularly competent to answer this question.

In view of the threatened boundary dispute between Quebec and Newfoundland, and in view of the fact that under section 92(10)(a) of the British North America Act any development of Hamilton Falls extending beyond the Province of Newfoundland would clearly fall within the legislative jurisdiction of the Parliament of Canada, can the Acting Prime Minister tell the House whether the Government has intervened or proposes to intervene to bring about a settlement of this dispute?

Mr. Muir (Cape Breton North and Victoria): He will have to check with Joey.

Hon. J. W. Pickersgill (Acting Prime Minister): Mr. Speaker, I am rather surprised that so eminent a lawyer as the hon. gentleman would ask a question of that kind, particularly as I am sure the hon. gentleman well knows that the development of power in any province is a matter which falls entirely with the jurisdiction of the province.

As far as any dispute about the boundary is concerned, I understand there has been some dissatisfaction expressed regarding the 1927 decision of the Privy Council, but I am sure the hon. gentleman would not expect me to express any views about that dissatisfaction.

isfaction 22620—81 Mr. Thomas M. Bell (Saint John-Albert): I have a supplementary question, Mr. Speaker. In view of the fact that the Minister is travelling east tomorrow and will want to make the most favourable impression possible, will he consider referring to the Atlantic Development Board, or some other agency, the possibility of Federal subsidies in respect of communication lines through the Maritime Provinces in order to end this stalemate over the Churchill Falls development?

Mr. Pickersgill: Mr. Speaker, I do not think we should consider subsidies until we find out whether something can be done without them. Reports indicate this project would be economically feasible.

Mr. Bell: Does the Minister think he is going to create a favourable impression when he arrives in the east as a result of his—

Mr. Pickersgill: Certainly, Sir; I am quite sure that the Minister's arrival in Fredericton tomorrow to open the airport will create a very favourable impression.
