Has his attention also been called to the fact that all five of the men who have held the position of president of the Canadian Union of Students have said they were similarly solicited, and that one of them said he was offered a bottle of rye whiskey?

I should like to ask the minister whether he will undertake to have an investigation made of these allegations to see whether they are true. If he finds they are correct, will he undertake to report back to the house to the effect that these practices are being discontinued?

**Hon. L. T. Pennell (Solicitor General):** Mr. Speaker, in reply perhaps I may be permitted to say that I am advised the R.C.M.P. does not supply funds to students or student organizations for the purpose of inducing them to act on behalf of the R.C.M.P.

I wish to emphasize that the activities of the R.C.M.P. are limited to counterespionage. Obviously it is not possible for the R.C.M.P., which is charged with the responsibility for national security, to carry out its responsibilities unless members of that force are able to ask questions of people who have relevant information. The R.C.M.P. have openly interviewed people from all walks of life, including students.

**Some hon. Members:** Hear, hear.

**Mr. W. H. A. Thomas (Middlesex West):** Would the Solicitor General also be prepared to advise the Canadian Union of Students that since the R.C.M.P. is one of the arms of government and is vitally responsible in the maintenance of law and order in this country, co-operation with the R.C.M.P. is co-operation with the government and the citizens of Canada?
