Hon. J. J. Greene (Minister of Energy, Mines and Resources): We shall be in constant touch with the industry. I believe we are in continuing consultation with Washington with respect to their current review of policy. As the hon. member knows, a good deal of the future well-being of the oil industry in Canada depends on United States policy and the attitude they take toward the present quota system. In these circumstances I believe the best service we can do the Canadian industry is to make sure that our views are made known in Washington as strongly and as effectively as possible, and this we certainly intend to continue to do.

NORAD-OPPORTUNITY FOR DEBATE OF AND CANADIAN PARTICIPATION IN AIRBORNE WARNING

I would like to ask the right hon. Prime Minister whether he would give assurance to the house that the government will not enter into any arrangement with regard to participation in the air warning and control system without first having the matter debated in parliament?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, we have taken the position that further progress toward the definition of defence policy will be announced in due course, and of course members of the house will have an occasion to discuss it.

Mr. J. M. Forrestall (Dartmouth-Halifax East): Mr. Speaker, in light of the widespread press interpretation of the remarks of the Minister of National Defence and of the Secretary of State for External Affairs last night, may I ask the right hon. Prime Minister whether the government has now concluded in its defence policy review the necessity for some form of continual role in NORAD, and particularly in the U.S. proposals for airborne warning and control through the 1970's?

Mr. Trudeau: Mr. Speaker, I cannot comment on the press interpretations that the hon. member refers to, not having been made aware of them and not having read them, but I can say that the policy has not yet been finally decided by the government.
