# MAINTENANCE OF SAFETY STANDARDS FOR PLANES IN LIGHT OF STRIKES

Mr. Duncan M. Beattie (Hamilton Mountain): Mr. Speaker, my question is for the Minister of Transport. In light of a recent statement by an Air Canada spokesman that the supervisory personnel are getting tired maintaining the planes, can the minister assure the House that an adequate level of safety for those who can still travel by Air Canada is being maintained?

Hon. Jean Marchand (Minister of Transport): Yes, Mr. Speaker, the department is doing all it can in order to assure that the safety standards are respected by Air Canada.

Mr. Beattie (Hamilton Mountain): Mr. Speaker, can the minister tell the House how regularly he receives safety reports concerning Air Canada, and when he received the latest one?

Mr. Marchand (Langelier): They are received on a daily basis, Mr. Speaker.

### ROTATING STRIKES BY MACHINISTS—REDUCTION OF NUMBER OF FLIGHTS—POSITION OF NEGOTIATIONS

Mr. Lincoln M. Alexander (Hamilton West): Mr. Speaker, I should like to direct a question to the Minister of Labour concerning the labour dispute involving Air Canada. In light of the fact the situation is being drastically changed in that, in addition to being faced with rotating strikes, Air Canada is cutting back the 550 flights for tomorrow by 30 per cent, and keeping in mind that the minister said on Friday the parties were getting closer to an agreement, can the minister now advise whether in fact the parties are closer to an agreement and, if not, what are the obstacles that are separating the parties?

Hon. John C. Munro (Minister of Labour): Mr. Speaker, I would advise the hon. member that I was in touch with the mediator, Mr. Bernard Wilson, a few hours ago. The report is quite encouraging and I am hoping, as I indicated on Friday, that this dispute will soon be resolved. On the basis of his report I think there is a basis for such encouragement.

Mr. Alexander: Mr. Speaker, perhaps I am not overly optimistic, but the preamble to my question still stands. In view of the fact the chairman of the board, Mr. Pratte, has indicated that if strikes are going to continue it may be necessary for Air Canada to shut down its services completely, a statement which is certainly verified by Mr. Baldwin, is the minister prepared to allow this to happen and, if not, what does he intend to do in order to avert such action?
