POSSIBILITY OF STRIKE OF NURSES—CONTINGENCY PLANS TO PROVIDE SERVICE TO REMOTE AREAS

Given the remote location of many northern nursing stations and the difficulty of supplying alternative services in the event of an early strike of federal nurses, a strike which could come as early as next week, will the minister indicate if a contingency plan has been developed to ensure that medical services will be available on a continuing basis to these remote northern communities.

Hon. Judd Buchanan (Minister of Indian Affairs and Northern Development): Mr. Speaker, I will have to pursue this matter with my colleagues. I understand the majority of these nurses are in designated positions. I assume that would cover our nurses in the north.

ADVERTISEMENT OF SAFEWAYS TRAVEL AGENCY CONCERNING PASSPORTS AND CITIZENSHIP—REQUEST FOR INVESTIGATION

Mr. Benno Friesen (Surrey-White Rock): Mr. Speaker, in the absence of the Secretary of State may I direct my question to the Acting Prime Minister. I have in my hand the April issue of a magazine called *Indo-Canadian*. On page 5 appears an advertisement by Safeways Travel Agency which is laid out in part as follows:

We Arrange Passport:—
Canadian—4 days.
Citizenship: Canadian—30 days.

Mr. McCleave: And all for \$5.

Mr. Friesen: Does that tavel agency have a special arrangement with the government. If so, will the Acting Prime Minister tell the House what it is.

An hon. Member: A Liberal lawyer.

Hon. Mitchell Sharp (Acting Prime Minister): Mr. Speaker, the answer to the question is, no, there is no such arrangement.

Mr. Friesen: Mr. Speaker, may I direct my supplementary question to the Minister of Consumer and Corporate Affairs. If there is not an arrangement with the government, will the minister investigate this travel agency, to see what kind of breach of advertising ethics is involved in this particular advertisement.

An hon. Member: Lay a charge.

Hon. André Ouellet (Minister of Consumer and Corporate Affairs): Mr. Speaker, the officials of my department are already looking at this matter and, as I understand, they are exploring avenues to reimburse people who have been adversely affected. As soon as I have further details I will communicate with the hon. member.
