## ANTI-INFLATION PROGRAM

POSSIBILITY OF NEW MEASURES TO ENCOURAGE INVESTMENT—GOVERNMENT POSITION

**Mr. Sinclair Stevens (York-Simcoe):** Mr. Speaker, as Jean-Luc Pépin, Chairman of the Anti-Inflation Board, stated last week, wage and price controls have hurt business investment in Canada; and as the Minister of Finance stated today, speaking in Toronto: "There is no question that we need a progressive recovery in private investment if we are going to be able to provide adequately for job creation and rising productivity", and then added: "The control of profit margins has been no tonic for investment", will the Prime Minister indicate whether, based on these statements, we may expect new directives for the AIB which would be designed to encourage private investment in Canada with its resultant much needed job creation?

**Right Hon. P. E. Trudeau (Prime Minister):** Mr. Speaker, I would have to take a look at the statements quoted by the hon. member. My information is that there is no hard evidence that the controls have in fact reduced the level of investment in Canada which there otherwise would have been, or that there has been any great misallocation of resources.

**Mr. Stevens:** Mr. Speaker, would the Prime Minister indicate whether the Minister of Finance in his speech in Toronto today was reflecting government policy when he stated:

—that the start of the solution to most of the economic challenges we face lies in more capital investment . . . Enhancing the role of investment is going to be an important item on our agenda for 1977.

Is that government policy?

**Mr. Trudeau:** Mr. Speaker, that seems like a pretty sound statement. I cannot say what the rest of the speech was, but that part taken in isolation seems to make good sense to me.
