Madam Speaker: Order. The hon. member is suggesting that one would need legal experience in order to interpret the rules of the House. I would challenge that statement.

Mr. Waddell: Madam Speaker, on a point of order—

An hon. Member: Sit down.

Madam Speaker: I cannot hear the hon. member commenting any more on the ruling I have just made.

PETITIONS

MR. SHIELDS—EFFECT OF BUDGET ON CITIZENS OF FORT McMURRAY

Mr. Jack Shields (Athabasca): Madam Speaker, I have the duty to present a petition on behalf of a number of constituents who live in the city of Fort McMurray in northeastern Alberta. The purpose of this petition signed by 8,285 citizens of the riding of Athabasca is to petition the government to recognize the unique role which Fort McMurray plays in the development of the Athabasca oil sands megaprojects and the devastating effect that the November budget will have on the residents of Fort McMurray who, because of the city's relative isolation, experience costs for goods and services 20 per cent higher than in Edmonton, 500 kilometres south.

The nature of the petition is to request that the government take action to reinstate tax exempt employee benefits used to attract workers to Fort McMurray, such as interest-free loans for home purchases, vehicle allowances, subsidized rents and utilities, etc. The petitioners hope, in Madam Speaker's examination of this petition, that you will find the petition in order, sense the urgency of their plea, and that you might use the discretionary powers vested in your office to allow discussion and referral of this petition to the Standing Committee on Finance, Trade and Economic Affairs at the earliest possible moment.
