## PUBLIC SERVICE

SIXTH, SEVENTH AND EIGHTH REPORTS OF JOINT COMMITTEE TABLED

Hon. John J. Connolly, for Hon. Maurice Bourget, Joint Chairman of the Special Joint Committee on the Public Service, tabled the following reports of the committee:

The Sixth Report, on Bill C-170, respecting employer and employee relations in the Public Service of Canada;

The Seventh Report, on Bill C-181, respecting employment in the Public Service of Canada; and

The Eighth Report, on Bill C-182, to amend the Financial Administration Act.

Hon. A. J. Brooks: Honourable senators, may I ask the honourable Leader of the Government (Honourable Mr. Connolly, Ottawa West) if the study of any or all of these bills has been completed in committee and, if so, when we might expect to receive them?

Hon. Mr. Connolly (Ottawa West): My understanding is that that is the position, and that the bills are soon to be reported to the House of Commons. Honourable senators will understand that these bills are not before this house at this time. After their presentation in the House of Commons they must be considered there by the committee of the whole tors, may I ask for the indulgence of the

house, and thereafter receive third reading. What I have tabled here today are reports containing amendments that have been made to the bills in committee, and in a few minutes I shall be moving that these reports be incorporated in today's Minutes of the Proceedings so that honourable senators will have these amendments available to them prior to the reprinting of the bills to which they

Hon. Mr. Brooks: In that connection may I ask whether we shall receive the bills individually or all three at one time?

Hon. Mr. Connolly (Ottawa West): I would think that we will get them seriatim. They may actually be presented to us in one group -depending a good deal upon when the Senate is sitting—but we are not committed to taking them one after the other or in any special order. They are three pieces of legislation, three independent bills, that emanate from one joint committee.

Hon. Mr. Brooks: And they will be considered independently and at different times?

Hon. Mr. Connolly (Ottawa West): Yes. It would not be my intention to move all three at the same time; in fact, it would be quite improper to do so.
