Page 1, line 7.—After (" Act ") insert (" one of.")

Page 1, line 9 —Leave out from (" Trade ") to (" shall ") in line ten, and insert (" to be determined by ballot by the members of the said Board.")

Page 1, line 16.—Leave out from (" shall ") to the first (" The ") in line 23, and insert (" be elected as at present provided by law : Provided always that the rotation shall be every four years instead of every five years as at present provided.")

Page 1, line 38.—Leave out (" indemnity ") and insert (" salary.")

Page 2, line 27.—After (" Interest ") insert Clause A.

Clause A.

(" Any thing inconsistent with this Act contained in the Act mentioned in the preamble hereto, is hereby repealed.")

After some time the House was resumed, and

The Honorable Mr. *Alexander*, from the said Committee reported that they had gone through the said Bill, and had directed him to report the same with certain amendments. And the said amendments being read a second time were agreed to.
