VI. And be it further enacted, That an Act made in the Thirty-ninth Year of the Reign of His present Majesty, intituled, An Act to revive and continue, until the End of the next Seffion of Parliament, an Act, made in the Thirty-fith Year of the Reign of His present Majesty, to continue and amend an Act, made in the Twenty-sixth Year of the Reign of His April 5, 1802- present Majesty, intituled, An Act for the more effectual Encouragement of the British Fisheries; and to amend an Act, made in the Twenty sixth Year of the Reign of His present Majesty, for extending the Fisheries, and improving the Sea Coasts of this Kingdom, which was amended and continued by an Act of the Thirty-ninth and Fortieth Years of the Reign of His present Majesty, until the Fifth Day of April One thousand eight hundred and one, be revived and continued, and the same is hereby revived, and shall continue in full Force and Effect from and immediately after the said Fifth Day of April One thousand eight hundred and one, until the Fifth Day of April One thousand eight hundred and two.

VII. And be it further enacted, That so much of an Act made in the Twenty-seventh Year of the Reign of His present Majesty, intituled, An Act for making Allowances to the Dealers in Foreign Wines, for the Stock of certain Foreign Wines in their Possession, at a certain Time upon which the Duties on Importation have been paid; and for amending several Clarke's Hydre- Laws relative to the Revenue of Excise, as directs that all Spirits shall meter, shall be her described as directs that all spirits shall be deemed and taken to be of the Degree of Strength at which the Hydrometer commonly called Clarke's Hydrometer, shall, upon Trial by any Officer or Officers of Excise, denote any such Spirits to be, which was to continue in Force until the Fifth Day of April One thousand seven hundred and eighty-eight, and which, by several subsequent Acts, was continued until the First Day of June One thousand eight hundred and one, shall be made perpetual.
