the tragic South African situation because of his desire to be in a position to mediate at the forthcoming prime ministers' conference in London?

Mr. Diefenbaker: Mr. Speaker, I will make no attempt to comment on a press report but, in saying that, I would not go as far as the statement in question implies according to the reading thereof by the Leader of the Opposition.

Mr. Pearson: Mr. Speaker, may I ask the Secretary of State for External Affairs, in the light of what the Prime Minister has said, whether he is now willing to revise the statement he made in the house on February 16, as reported at page 1139 of Hansard of that date:

Today it would be extremely hard to find two nations between which Canada could be a gobetween.

Mr. Speaker: I think the Leader of the Opposition will appreciate that that is not an appropriate contribution to the proceedings at this stage because it is an argumentative question.

Hon. Paul Martin (Essex East): Mr. Speaker, I should like to ask the Prime Minister a supplementary question in view of the reply which he has just given to the Leader of the Opposition on the question of apartheid in South Africa. Will the Prime Minister now revise the statement he made in this house in reply to a question I put to him earlier in the session to the effect that he would not initiate any discussion of this matter at the prime ministers' conference?

Mr. Diefenbaker: Mr. Speaker, the hon. gentleman knows that what takes place at the prime ministers' conference is secret. I am glad to notice the tremendous interest of the hon, gentleman in apartheid because I seem to recall that on a number of occasions when he was one of the representatives at the United Nations in New York and the vote took place on the South African question, he led in Canada's position about taking no attitude and having no vote thereon.

Mr. Martin (Essex East): Mr. Speaker, may I thank the Prime Minister for this historical narrative and ask him if he proposes to initiate a discussion of this important matter at the prime ministers' conference?

Mr. Diefenbaker: Mr. Speaker, I expected that question to be asked and therefore in order to make sure that the historical record is correct I would remind the hon. gentleman that if he will look at the answer given by the former prime minister, the Right. Hon. I should like to direct another question to Louis St. Laurent, on June 22, 1956, with regard to prime ministers' conferences, he department contemplate an early closing of

Mr. Hees: I am sure, Mr. Speaker, that the islanders do not need the assistance of the hon, member for Laurier. If they want assistance from this government I am sure they will ask for it. If they ask for it, every consideration will be given, as always, to requests of this kind.

Mr. Chevrier: May I ask a supplementary question? Why, then, is the United States coastguard service going to the assistance of those people rather than the Canadian service?

Mr. Hees: Perhaps because they have a cutter in the immediate vicinity. I would say that would be the logical answer.
