REQUEST FOR TABLING OF STANBURY-FIELDS REPORT

Mr. Thomas S. Barnett (Comox-Alberni): Mr. Speaker, I have a question for the Minister of Indian Affairs and Northern Development on another matter.

Mr. Barnett: Mr. Speaker, my question for the minister concerns the request for tabling of the Stanbury-Fields report and the response of the parliamentary secretary during the adjournment debate on May 1 when he said in effect that the federal government would have tabled the report if it could have secured the concurrence of the government of British Columbia. Later a public statement by the British Columbia Minister of Municipal Affairs was reported in which he denied the allegation that the report was being kept confidential because the British Columbia government had not assented to its being made public. Would the minister recheck the information on which the statement of the parliamentary secretary was based? Alternatively, would he inquire whether the British Columbia government has changed its original position on this matter?

POSSIBILITY OF SUGGESTED MACKENZIE VALLEY CORRIDOR FOLLOWING PROPOSED HIGHWAY ROUTE—INQUIRY AS TO DISCUSSIONS

Mr. Eldon M. Woolliams (Calgary North): Mr. Speaker, having regard to the original question about an energy corridor down the Mackenzie Valley and the Prime Minister's announcement of a new highway to the north, may I ask him whether there have been any discussions or negotiations with regard to having the energy corridor follow that highway down through Alberta to bring energy supplies from the north to the industrial centers of Canada and elsewhere?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, when the member asks whether there were any discussions I am not sure with whom he means the discussions might have taken place. There were, of course, discussions within the federal government and cabinet, and the purport of my decision was to indicate that we would be planning the road and the Minister of Indian Affairs and Northern Development has already said that surveys are proceeding along that basis. The intention would be to have a road which preferably could be the core of such an energy corridor down the Mackenzie Valley.

PROGRAM TO CONTROL SWAMP FEVER IN HORSES—AMOUNT OF COMPENSATION

Mr. Maurice Foster (Algoma): Mr. Speaker, my question is for the Minister of Agriculture. Can the minister say whether the program for control of swamp fever in horses will be compulsory, and what compensation will be paid for infected animals?

Hon. H. A. Olson (Minister of Agriculture): Mr. Speaker, the requirement to have horses subjected to a test or indeed to be slaughtered should they show positive results from the test is not compulsory. There will be compulsory quarantine if a horse should have a positive reaction to the test. There will be a compensation program effective as of yesterday, and the details of the amounts will be announced shortly.

Mr. Foster: Would the minister consider making the compensation for these animals retroactive to January 1, 1971?

Mr. Speaker: Of course, that is a representation. The hon. member for Edmonton East.
