

which the hon. member mentioned, such as waitresses in restaurants—must purchase are manufactured by the manufacturing industry in Canada today, 80 per cent of which is centred in two or three large areas, and these two or three large centres, fortunately for Canada, have powerful unions and those workers can look after themselves, and if these groups are controlled and inflationary pressures are lessened, does he not agree that when they buy products low income earners elsewhere will benefit from this program?

**Mr. Orlikow:** I would give a good deal more thought to the question of the hon. member if he had expressed the same concern in the years 1972 to 1974 when corporation profits doubled, and when he and his government sat and said that that was a good thing. They should not now be saying that wages should be controlled.
